**4. First Aid Measures**

**Ingestion:**

If a person vomits place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth with water. Ensure that medical personnel are aware of the material(s) involved and are aware of precautions to protect themselves.

**Inhalation:**

Remove from source of exposure. Move individual(s) to fresh air. Give artificial respiration if individual(s) are not breathing and call emergency medical service. If signs of toxicity occur, seek medical attention. Provide symptomatic/supportive care as necessary. Ensure that medical personnel are aware of the material(s) involved and are aware of precautions to protect themselves.

**Signs and Symptoms:** Ocular burning and/or stinging; eye redness and itching; blurred vision and keratitis; dyspnea, respiratory failure, contact dermatitis, bradycardia, heart block, choroidal detachment following infiltration surgery and nausea.

**Medical Conditions Aggravated by Exposure:** Chronic respiratory and obstructive airway diseases, kidney problems, cardiac disease allergic reactions.

**Notes to Physician:** This product contains a sulfonamide (Dorzolamide hydrochloride) and a beta-adrenergic blocking agent (Timolol maleate), which are absorbed systemically. Symptoms consistent with systemic administration of beta-blockers or carbonic anhydrase inhibitors may occur, including electrolyte imbalance, development of an acidotic state, dizziness, headache, shortness of breath, bradycardia, bronchospasm, cardiac arrest and possible central nervous system effects. Serum electrolyte levels (particularly potassium) and blood pH levels should be monitored. Treat supportively and symptomatically.
